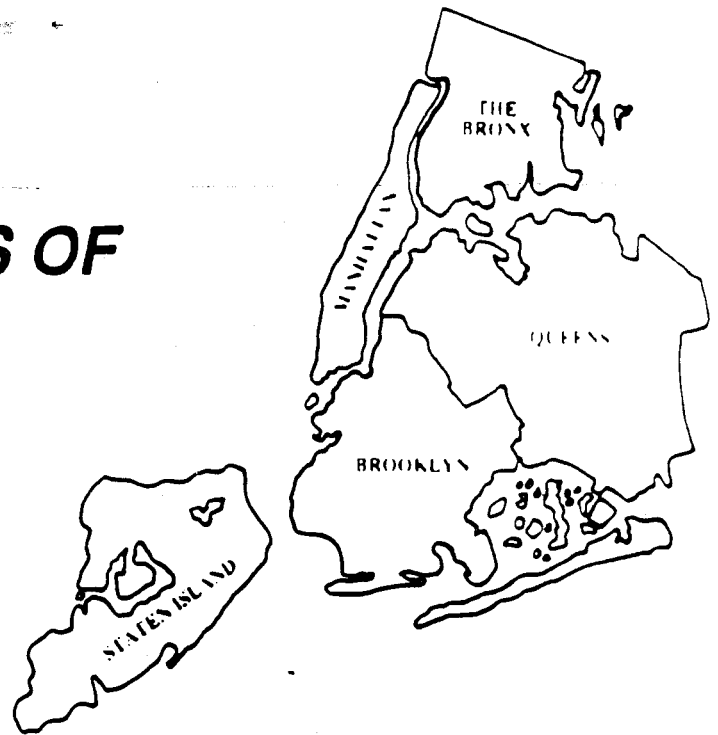

Minutes of the PANYC Executive Board Meeting 16 November 1994

President Linda Stone called the meeting to order at 6:30PM. The following committees will report to the General Membership meeting: Archives, Awards, Burial Ground, Exhibit, Membership, Native American Affairs, Newsletter, Public Program, and Research and Planning.

PRESENT: Cantwell, Dublin, Geismar, Harris, Rothschild, Stone, Wall, and Yamin

TREASURER'S REPORT: The treasurer reported a balance of \$1184.

SECRETARY'S REPORT: The following changes to the minutes of the last Executive Board meeting were made. In the President's Report, "Howard Winter" should be changed to Howard Winters; accordingly, in the following sentence, "Winter's" should be Winters'. In the Education Committee report, the first sentence should read "Stone discussed a press release about Gene Ritter's Coney Island project ..." Under New Business, the first sentence should begin "Geismar raised the issue of continuing PANYC involvement ..." The minutes were accepted as amended.

PRESIDENT'S REPORT: Copies of correspondence on behalf of PANYC are reprinted in the newsletter. Stone advised that she and Dublin are scheduled to meet with Jennifer Raab, the new commissioner of the NYCLPC, on 1 December 1994. She requested guidance from the Board on topics to be discussed; recommendations included the pending legislation, whether the LPC intends to hire a new counsel to replace Dorothy Minor, and whether there are plans to increase the archaeology staff beyond the current 1 1/2 lines. Stone received a notice that the Bioanthropology laboratory at Howard University will be arranging tours of the facility during the SHA meetings, and wondered whether PANYC members would be interested in scheduling a tour. The Board was very enthusiastic; the idea will be raised at the membership meeting. On behalf of the Board, Cantwell thanked Stone for arranging the showing of the African Burial Ground video for PANYC members.

MEMBERSHIP: The Board recommended that Killeen send out dues reminders to the membership.

NATIVE AMERICAN AFFAIRS: Cantwell reported that Deborah Poolaw, a Western Delaware, is now responsible for administering NAGPRA.

RESEARCH AND PLANNING: Harris reported that the PANYC symposium on reconstructing past landscapes was fairly well attended, not only by PANYC members but also by students and faculty from local universities. The speakers were excellent and there was lively discussion among speakers and audience members. The program and abstracts of the talks will be included in the next PANYC newsletter. The committee formally thanked Nan Rothschild for arranging the use of Barnard's Sulzberger Parlor; it was an excellent setting that no doubt contributed to the informal and lively tone of the day. Thank-you notes have been sent to the speakers. The committee is entertaining ideas for a topic for next year's symposium, assuming that the membership agrees that PANYC should sponsor another event of this type. A possible topic might entail excavation and collections management in the current era of NAGPRA, repatriation, and 36CFR Part 79. The Board agreed that the symposium was a success and that PANYC should sponsor another, perhaps

to coincide with the January meeting with NYAC. Stone commended the committee on its work.

OLD BUSINESS: Stone reported that phase II construction has begun at the ATURA site. She made a site visit and noted that a number of trenches have been dug for utilities. These are near the street; it is not clear whether the archaeologically sensitive backyard areas will be affected. She has drafted a letter to the Advisory Council regarding these events; the draft was passed around for Board members' comments.

No further business was brought before the Board.

Dear Mr. Klima:

I am writing in response to your recent letter regarding the Memorandum of Agreement (MOA) by and among the City of New York, the New York State Historic Preservation Office (SHPO) and the Advisory Council on Historic Preservation (Council), with respect to the Atlantic Terminal Partnership New Homes site.

In your letter, you suggest that the implementation of the Atlantic Terminal Partnership New Homes Project might have an effect on archaeological resources that are potentially eligible for inclusion in the National Register of Historic Places, and that the City, SHPO and the Council will need to determine whether the existing MOA should be amended or whether this matter should be handled as a discovery in accordance with 36 CFR 800.11.

You assert in your letter that the excavation on Phase I of the site is affecting previously "unidentified" archaeological properties. However, we have been informed by the Historical Perspectives archaeologists who prepared the 1985 Phase IA Archaeological Impact Report for the Atlantic Terminal and Brooklyn Center Projects that any of the resources which may have been uncovered by the excavation on Phase I of the site were, in fact, previously identified but not deemed significant based on the accepted archaeological standards used in 1985.


Since the requirements of 36 CFR 800.11 apply only where implementation affects previously unidentified property or affect a known historic property in an unanticipated manner, this matter should not be handled as a discovery under such section and consequently there is no need to amend the MOA.

As we explained in a recent letter to Linda Stone, President of Professional Archaeologists of New York City, although we do not believe that any further archaeological studies are required by law, HPD will ensure that an archaeological documentary study (including any field testing and recovery deemed necessary by the Landmarks Preservation Commission) is conducted of the Phase Two and Three portions of the New Homes site (approximately the southern halves of Blocks 2004, 2005 and 2006) before the construction begins on these properties.

This archaeological work will be conducted in accordance with the Landmarks Preservation Commission's "Guidelines for Archaeology" and the CEQR Technical Manual, in a manner consistent with the Secretary of the Interior's "Standards and Guidelines for Archaeological Documentation" and the Advisory Council on Historic Preservation's Treatment of Archaeological Properties. The properties will be properly secured during any archaeological field investigations.

Thank you for your recent letter requesting a reevaluation of archaeological resources within the Atlantic Terminal Partnership New Homes site. As you know, as soon as we received your letter, we ensured that the builder of the New Homes Project took all necessary steps to secure the site against trespassers.

Although we do not believe that any further archaeological studies are required by law, HPD will ensure that an archaeological documentary study (including any field testing and recovery deemed necessary by the Landmarks Preservation Commission) is conducted of the Phase Two and Three portions of the site (approximately the southern halves of Blocks 2004, 2005 and 2006) before the construction begins on these properties.


This archaeological work will be conducted in accordance with the Landmarks Preservation Commission's "Guidelines for Archaeology" and the CEQR Technical Manual, in a manner consistent with the Secretary of the Interior's "Standards and Guidelines for Archaeological Documentation" and the Advisory Council on Historic Preservation's Treatment of Archaeological Properties. The properties will be properly secured during any archaeological field investigations.

As you know, however, the excavation and foundation work has already been completed for the Phase One portion of the site. Accordingly, construction will continue on this property without any further archaeological studies.

Dear Mr. Klima,

I am writing to you once again on behalf of Professional Archaeologists of New York City (PANYC) regarding the Atlantic Terminal/Brooklyn Center project in the Fort Greene section of Brooklyn. It has come to our attention that this project continues to be developed and is now in construction phase 2, in violation of the law (see attached photograph). This means there is further possibility for the loss of archaeological data in areas adjacent to those previously looted. Your October 12, 1994 letter to Commissioner Wright of New York City Housing Preservation Development informing the City of its legal obligations has had no effect.

We request that any work which may affect the integrity of archaeological resources within this project area stop immediately, including removal of overburden that may enable looters to plunder the site. No further construction should be conducted until the applicable laws can be complied with. Additionally, no federal funding should be applied while this project is in violation of the law. We urge you to take prompt action on this serious matter before additional resources are destroyed.


Dear Ms. Stone:

I am writing in response to your November 17 letter to Don L. Klima of the Advisory Council on Historic Preservation regarding the start of construction on Phases Two and Three of the Atlantic Terminal Partnership New Homes site. Please be advised that as per Commissioner Wright's November 16 letter to you, construction on Phases Two and Three will not begin until the archaeological work described in her letter has been completed.

The work which you describe in your letter to Mr. Klima is either the construction of Cumberland Street or the removal of several gas tanks located near the corner of Atlantic and Carlton Avenues which had been leaking. In addition, please note that HPD had given permission to the developer of the Partnership Project to store material from the Phase One site on the Phase Two and Three sites on a temporary basis.

I am writing to you on behalf of Professional Archaeologists of New York City (PANYC) regarding the Municipal Reference Library located at 31 Chambers Street. We are dismayed to learn that continued funding for this library is in jeopardy under one version of the proposed city budget cuts. We urge you to consider the importance of maintaining a single repository for city documents. The documents in the Municipal Reference Library belong to the people of New York City and as such should be maintained together in one central location. It would be a tragedy to split up a collection made up of years of city records. This body of valuable information relating to our city's heritage could never be replicated or reassembled. While one alternative may be to dismantle the collection and distribute it to each borough, we would like you to consider the benefits of keeping all of the materials under one roof, easily accessible to the public. This library is an important resource and anything done to alter it would be more than unfortunate.

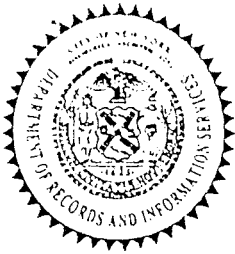

RE: Proposed Revisions to 36 CFR Part 800

Dear Executive Director,

I am writing on behalf of Professional Archaeologists of New York City (PANYC) in response to your request for comments on the proposed revisions of 36 CFR Part 800 - Protection of Historic and Cultural Properties. In general, we endorse the increased emphasis placed on early planning and the streamlining exemplified by the integration of Section 106 with internal agency planning procedures. However, of the issues you feel require special attention, we can only comment on those which most directly affect us; Public Participation, Role of Certain Interested Parties, Disputes Over Application of the Regulations, Reviews and Appeals, Treatment of Archeological Resources and Use of Information Technology.

The increased role of public participation in the Section 106 process under the proposed revisions is commendable. However we did not find adequate language with regard to how public participation and comment will be taken into account by agencies. Language regarding the weight of public comment should be added so there is no question about the authority of both the public and the agency officials as well as recourse for members of the public who feel they were not given due consideration in the Section 106 process.

The newly defined role of certain interested parties seems to be an improvement for property owners. However the role of "interested party" should not be limited to property owners. We agree that the resolution of disputes has often been problematic. However, particularly in the case of archaeological resources, the proposed changes do not seem to include Council consultation on disagreements with the Conditional No Adverse Effect finding. It appears that the Council would only consult on reviews and appeals when requested to do so by official interested parties or recognized members of the public. While this may provide "fair access to the Council", it does not give the Council a mechanism to participate effectively prior to this critical time. There may be instances when agency officials and SHPOs are in agreement differing from members of the public or, potentially, the Council. Language should be added regarding these types of situations.

Treatment of archaeological resources through the use of Conditional No Adverse Effect Determination (CNAED) could potentially be problematic. The proposed regulation does not include a documentation requirement for the CNAED, as opposed to No Adverse Effect, and it should. Furthermore, while the Council would be notified of the CNAED, there is no mechanism for Council follow-up. The unfortunate result appears to be a weakening of the regulatory process. The involvement of the Council at this stage has been critical in the past. Where the Council was previously an MOA signatory with regard to archaeological resources, they would have no role, not even as a back-up, under the proposed Section 106 changes. It is our opinion this definitely undermines the effectiveness of the system.

With the increased role in the Section 106 process defined for members of the public, information

dissemination is a critical issue. We support the establishment of a central point of contact for this. An Internet Bulletin Board or something similar, adaptive to changing technological capabilities, could list undertakings.

In addition to the issues you have considered, we also have other concerns. Although we understand the Council's need to free personnel from routine matters, we fear chaos will ensue. As mentioned above, the main concern with the elimination of the Council as a signatory to MOAs is whether there exists sufficient authority to overcome potential local political concerns. This of particular concern in more rural areas where groups such as PANYC do not exist or where local community participation is less active. In many instances, the Council's input is extremely important. While the proposed guidelines do provide an avenue for soliciting the Council's participation, we fear there is potential for important considerations to be ignored. We trust the proposed changes will realistically addresses this issue.

We hope our comments will be considered in finalizing the proposed changes to 36 CFR Part 800. We understand that an extension of the deadline for comments is being extended, upon request, for a period of one month. PANYC formally requests this courtesy as further discussion may produce additional comments.

Thank you for the opportunity to provide you with input on the proposed revisions. Please let us know how we may obtain a copy of either the revised "proposed rules" or the revised regulations, as appropriate.

THE URBAN REPORT CENTER

The Urban Archaeology Group announces the establishment of a center for the distribution of reports in urban archaeology. This center was established to address the problem of the general lack of availability of contract reports, and to insure that researchers can access the latest developments in this young specialty.

Individuals and firms may participate in the center by submitting a legible, unbound copy of each contract report they wish to have entered in the center. Each report should be accompanied by a signed release that gives the center permission to photocopy the report and distribute it on an at-cost basis. Copyrighted material must be accompanied by a signed and notarized release from the copyright holder. A set of descriptive key words should also be submitted for each report.

Each report will be entered into a Hypercard (Macintosh) based bibliography. This computer bibliography will be the source of a printed bibliography of reports on file that will be distributed to the membership of the Urban Archaeology Group on a regular basis. The list will be also be available upon request.

The bibliography will include the cost of each report calculated at the rate of seven cents (\$0.07) per page plus postage. A copy of the bibliography will be available in Hypercard on a 3.5" data disk for the cost of a replacement disk and postage, which will allow those with the proper hardware and software to perform their own bibliographic searches and compile customized bibliographies.

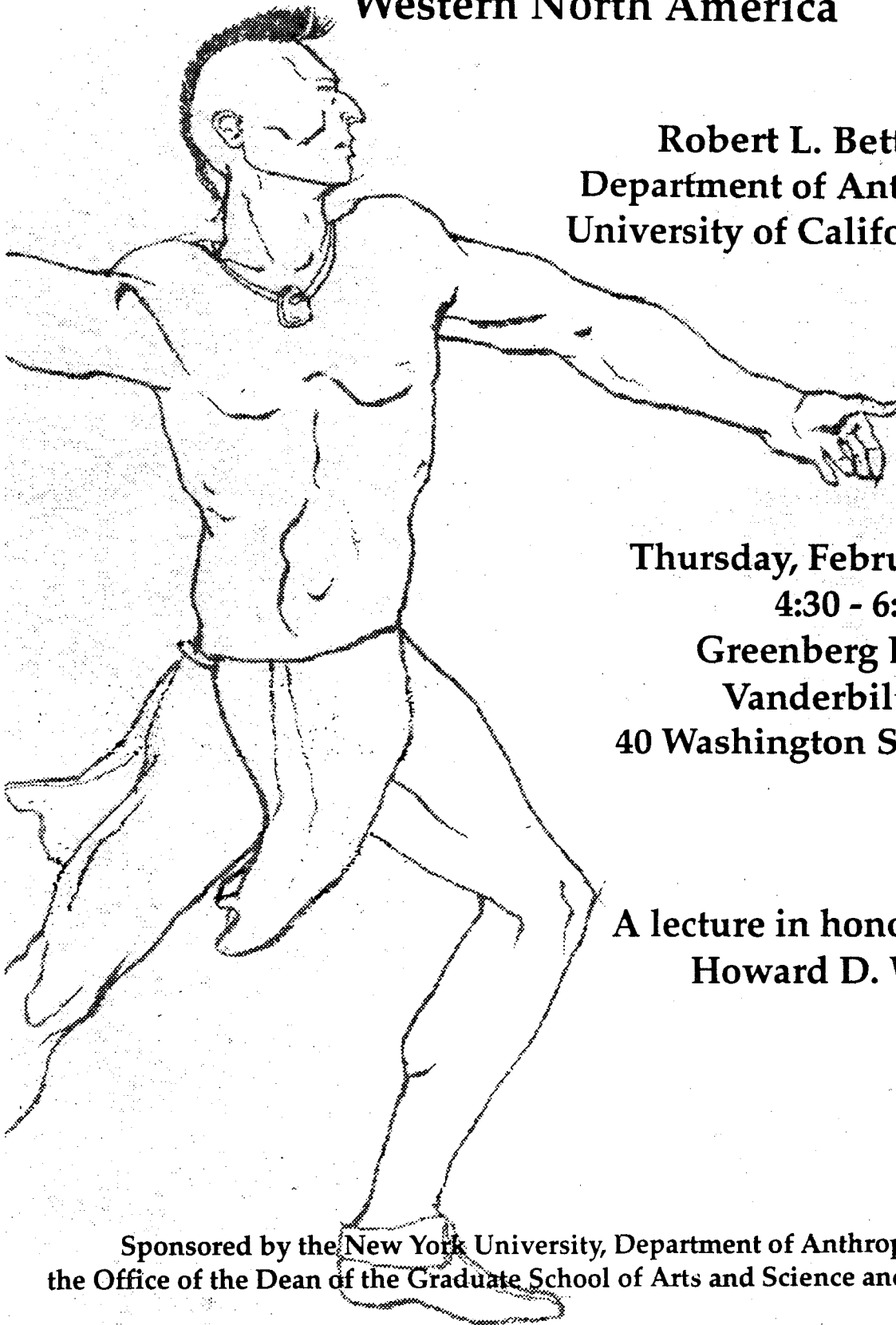

- c. Applicants must demonstrate professional experience in one or more areas of archaeological activity, such as: field research and excavation, research on archaeological collections, archival research, administration of units within public or private agencies oriented toward archaeological research, conduct of cultural resource management studies for public agencies, or teaching with an emphasis on archaeological topics. Applicants meeting the education and training criteria and having other professional interests related to archaeology will be considered on a case by case basis.
- d. All prospective applicants must be approved by a majority of members present at a regularly scheduled meeting of the general membership.
- e. Applicants should submit a statement of purpose that includes their interest in New York City archaeology. Members of PANYC have a commitment to protect and preserve the city's archaeological resources and to support research and encourage publication of information recovered from those resources. Members will not engage in illegal or unethical conduct involving archaeological matters. In applying for membership it is expected that an individual is in agreement with these goals. PANYC is not an accrediting organization and is not to be used as such.

Application for membership shall be in writing and shall include a copy of the applicant's resume or *vita*.
