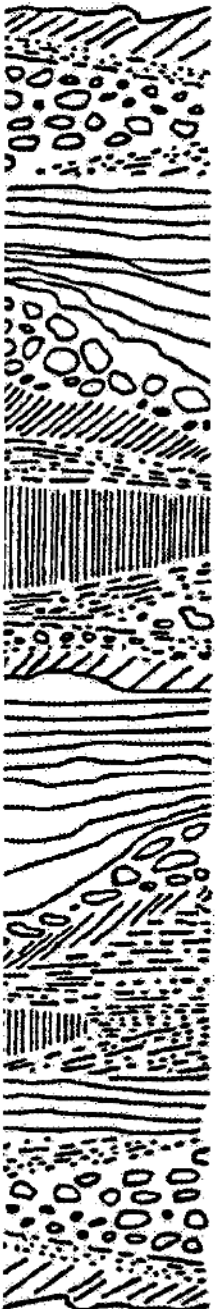

PANYC membership is open to any professional archaeologists who subscribe to the purpose of the organization and who meets the criteria set forth in this application form. PANYC offers Full and Adjunct Membership. Applicants for Full Membership must have been awarded one of the following advanced degrees: M.A., M.S., M.Phil., Ph.D. D.Sc., or is A.B.D, from an accredited institution in archaeology, anthropology, history, classics, or other related discipline with a specialization in archaeology or an equivalent. Applicants for Adjunct Membership must, at the time of application, be enrolled and working towards an advanced degree as described above or employed in the field of archaeology, history, or other related discipline with an academic institution, government agency, museum, or cultural resources management firm. Full membership is required for voting privileges.

Members of PANYC have a commitment to protect, preserve and document New York City's archaeological resources and to support research and encourage publication of information recovered from those resources. Members will not engage in illegal or unethical conduct involving archaeological matters. In applying for membership, an individual must be in agreement with these goals. Prospective members should understand that PANYC is not an accrediting organization and is not to be used as such.

Application for membership shall be in writing on this form accompanied by a copy of the applicant's resume or *vita*. All prospective applicants must be approved by a majority of members present at a regularly scheduled meeting of the general membership.

Applicants who have not completed an accredited field school can qualify for membership by demonstrating equivalent field and laboratory training under professional supervision.</p>
